

Scholars & Students Origin, Fields, Destination, Trends

U.S. 2006/07/08

- **Scholars:** **Italy** ranks 8th with a 4% increase from 06 to 08 and having 3% of the total population of international scholars, followed by Spain and the U.K. respectively

Leading countries: China, India, Japan, South Korea and Canada

China ranks 1st with 18% increase from 06 to 08 and 22.4% of the total number of international scholars.

Leading fields of specialization: Biology, Biomedical, Health Sciences, Engineering, Physical Sciences and Agriculture.

Leading Institutions (12): Harvard U., Stanford U., U. of California-Berkeley, U. of California-Davis, Columbia U., U. of California-Los Angeles, U. of California-San Diego, Yale U., U. of Michigan-Ann Arbor, U. of Washington, U. of Florida, and the Massachusetts Institute of Technology (M.I.T.)

Graduate Students: Total Increase of only 4.3% from '07 to '08.

Increase: China 14% as compared to 19% in 2007

Decline: India - 2%; South Korea - 4%

Three Different Models (Slide 1)

Project-Based/Problem Solving

Worcester Polytechnical Institute (WPI) – Worcester, MA (private institution)

- Global Perspective Program (GPP) – Project specific in 25 locations in five continents. Offered to undergraduate in multidisciplinary groups with faculty mentor. Integrated into the program of studies, includes industry partners and requires problem solving.
- Italy location: Venice where students worked on helping to reduce damage to canal walls and to catalogue endangered public art.

Three Different Models (Slide 1)

- **Centralized Approach with Campus Abroad**

*Georgia Institute of Technology (Georgia Tech) – Atlanta, Georgia
(public university)*

- The goal is to articulate a vision of a “multinational university”
- The Office of International Education under the leadership of a Vice-Provost for International Education supports hundreds of Study-Abroad programs around the world. Also provides support for faculty bringing graduate students, visiting scholars, or wishing to internationalize their particular area of interest. Provides logistic support as well
- International curriculum for undergraduates through the International Plan Designation (IP) which appears on their title, upon graduation
- Requires at least 26 weeks of study, internship and research abroad.
- Passing an oral proficiency exam certified by the American Council on the Teaching of Foreign Languages (ACTFL)

Three Different Models (Slide 2)

From Decentralized to Centralized:

University of Illinois, Urbana-Champaign – (public land/grant university)

Creation of high level International Advisory Council

Office of the Associate Provost creating a database on the Web,
a catalogue of all

international programs at Illinois.

Institute an additional fee of \$5.- each semester for education
abroad scholarships

Will raise \$900,000 in three years

Has over 100 partnerships across the world with Government's
Research Institutes (CNRS)

France, for joint research projects.

Three Different Models (Slide 2)

Established: Global Connect: Small office with a modest budget of approx. \$100,000

To help new faculty to pursue grants, partnerships and international opportunities.

Launched: Academy for Global Engagement : (2006)

Select eight faculty fellows from different disciplines for a year long immersion in international affairs. Organize monthly seminars, visit headquarters of multinational corporations in Chicago, and international agencies in Washington D.C.

Capstone: An international trip at the end of the year to collaborate on a short-term research and education project. First group went to Mexico to explore the anti-diabetic properties of certain plants.
