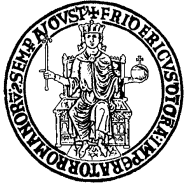

**ARTICLE 1 (Award)**

### ARTICLE 2 (Participation requirements)

Research grants are destined to those who possess:

- PhD
- Master Degree in Civil /Mechanical/Materials Engineering
- younger than 35 at the application deadline.

In the case of candidates whose Ph.D. has been awarded abroad, the committee of Center will assess the qualifications for the sole purpose of the selection procedure.

Candidates must be in possession of the required qualifications at the application deadline.

Research grants cannot be awarded to staff members of the University, of public bodies and research and testing institutions, of the national agency for new technologies and the development of sustainable economic development (ENEA) and of the Italian Space Agency (ASI), as well as of institutions whose post-graduate scientific qualification has been recognized as equivalent to a research doctorate in accordance with Art. 74, comma 4, of D.P.R. 11 July 1980 n. 382.

Pursuant to Art. 18, comma 1, lett. b) and c) of Law n. 240 dated 30 December 2010, research grants cannot be awarded to those related by marriage, consanguinity or affinity, up to fourth degree relations, to teaching staff from the department/research center or institution that is proposing to offer the contract, the Dean, the Director General or member of the University Board of Directors of the University Federico II.

### ARTICLE 3 (Applications and deadlines)

If you intend to compete for multiple selections of research grants with different identification numbers, you will need to produce as many applications, together with the relevant attachments, which will be sent in separate envelopes. In case multiple research grants with different identification numbers are indicated in the same application, the one indicated first will be considered valid.

Applications must be in **two signed copies** (an original and a copy), as set forth in Annex B to this notice. They must be personally signed by the candidate, and must state the following:

- A. the candidate's name, last name, date and place of birth, nationality, and place of residence;
- B. details of the competition for which the candidate intends to apply: the specific indication of the identification number of the competition, the structure of the research center, the sector and the disciplinary field;
- C. possession of the title of philosophiae doctor (PhD) (i.e., for the sectors concerned, the specialization of a health area accompanied by adequate scientific production pursuant to n. 509/99 and integration) or degree referred to in the academic regulation;
- D. Master Degree in Civil /Mechanical/Materials Engineering gained no earlier than three years ago at the application deadline;
- E. that he or she is not an employee of University, at public bodies and research and testing institutions, at the national agency for new technologies and the development of sustainable economic development (ENEA) and at the Italian Space Agency (ASI), as well as at institutions whose post-graduate scientific qualification has been recognized as equivalent to a research doctorate pursuant to Art. 74, comma 4, of D.P.R. 11 July 1980 n. 382;
- F. that he or she does not fall within any of the situations of incompatibility set forth in Article 18, paragraph 1, letters b) and c) of Law 240/2010: that is, that he or she is not related by kinship (up to and including the fourth degree) or by marriage to a Professor who belongs to the Department that has issued the call or that is the location where the research will be conducted, or to the Rector, the Director-General, or a Member of the Board of Governors of the University of Naples Federico II;
- G. the address at which he or she wishes to receive communications concerning the competition, the telephone number, the e-mail address, the tax code, and the commitment to promptly notify any change in the mentioned address.

Candidates who wish to avail themselves of the opportunity of having their interview conducted on Skype must state as such on their application, and must provide their Skype contact ID.

Candidates should declare, under their sole responsibility and pursuant to articles 46 and 47 of the Presidential decree dated 28 December 2000, n. 445: (Annex. C), together with a photocopy of an identification document:

- 3) a list, drawn up in duplicate, of the publications and qualifications attached to the application (publications and qualifications must be numbered progressively and each of them must bear the corresponding number in the list).
- 4) a short research proposal (max 2 pages) from the candidate based on the attached abstract.

The qualifications referred to in points 1) and 2) may also be produced by means of a copy of the declarations stated as in accordance with the original together with a substitute declaration of a notorious act at the bottom of the copy itself or made in accordance with Annex D of this notice. In both cases a photocopy of an identification document must be attached.

The publications and thesis described under 3) above may also be attached in the form of copies that have been self-certified in the manner indicated above.

Applications that do not contain the declarations referred to in points (a), (b), (c) and (e) and to which the required documentation is not attached **will not be taken into consideration**, and will therefore be excluded.

The administration office will accept no liability for the loss of communications due to the applicant having provided incorrect details of his or her residence and address, to his or her failure to provide, or any delay in providing, notice of changes, or to any cases of postal or telegraphic malfunction that cannot be attributed to the University Administration.

Candidates will have to collect the documents and any publications enclosed with their application within three months following completion of the selection process. After this period has passed, the Administration will destroy the above-mentioned documents and publications.

**ARTICLE 4 (Examining board)**

The examining board is appointed (for each scientific area) by decree of Center's Director, on a proposal from Scientific and Technical Committee, and it will consist of three permanent and two substitute members chosen from university professors and researchers.

The examining board may consult highly-qualified Italian or foreign experts external to the University, provided that this entails no additional charge to public funds.

**ARTICLE 5 (Selection Procedure)**

Selection of candidates is based on a joint comparative evaluation of the qualifications presented and an interview.

The examining board, in their comparative evaluation, can assign 100 points: 70 for the qualifications held and 30 for the interview.

**ARTICOLO 6 (Evaluation of Qualifications)**

The examining board subdivide the 70 points reserved to qualifications according to specific criteria:

- 1) Up to 10 points for the PhD qualification, considering the judgement expressed by the final examination board and pertinence of the research activity;

- 2) up to 15 points for further university qualifications (undergraduate degrees, other PhDs, specialization diplomas, master's degrees), as they relate to the relevance of said qualifications to the research activities to be undertaken;
- 3) Up to 40 points for the scientific publications, taking the following criteria into consideration: originality and innovative nature of the scientific work and its methodological accuracy; the compatibility of the candidate's profile with the notice; and the scientific status of the publishers of the publications and their diffusion within the scientific community;
- 4) Up to 5 points for certificates for post-graduate courses and for other qualifications associated with documented research activities for government and private organizations in Italy and abroad (up to a maximum of 3 points for each certificate or qualification). The evaluation of qualifications will, in any case, take place before the interviews begin.

Candidates will be called for interview provided that they score at least 35 points over 70.

The results of this evaluation will be posted, before the interview, on the University website (<http://www.dist.unina.it/>).

The opportunity of taking the interview by video-conference will be given to the foreign applicants. Even in this case the identification of the candidate and the public interview will be ensured.

**The schedule of the examination is attached to the call and is official. No other communication will be sent to candidates.**

**ARTICLE 7 (Formation of the ranking list)**

The results of the qualification assessment will be published on **25 March 2019** on the online section of the official register of the University and on website ([www.dist.unina.it/esiti](http://www.dist.unina.it/esiti)) and at the library door of the Department. The admitted candidates will be to take the interview on **March 26<sup>th</sup> 2019 at 3.00 pm** at Department of Structures for Engineering and Architecture.

The publication of the calendar on this announcement represents an official notification and candidates will not receive any other notifications about it.

The interview will be deemed to have been passed if the candidate is awarded a score of at least 24 out of 30 points.

The ranking list is draw up, in descending order, based on the total scores obtained by each candidate in the evaluation of qualifications and interview. In instances where are two or more candidates having the same score, the youngest candidate will prevail.

The research grants are awarded within the number of places put into competition according to the ranking.

In the event the award is not accepted by the deadline identified in Article 8 or is turned down before the research activities commence, the grant will be awarded to the next ranking candidate in the classification order.

**ARTICLE 8 (Start Date and Activities and Obligations of the Grant Recipient)**

The successful applicant will be given notice of the manner in which his or her contract must be signed. He or she must sign the agreement within the essential deadline of fifteen days after receipt of the above notice, under penalty of cancellation.

The grantee must undertake his/her research within the framework of research programs approved by this notice of competition.

The Center's Board, where the holder of the grant must carry out his activity, identifies a professor or a university researcher responsible for that activity. The Center's Board will decide on the project design at the time the grant is awarded, and at the beginning of each years, as proposed by the Head of Research.

With the exception of the cases listed in the final paragraph of Article 9, the research activities associated with this grant must commence, without any possibility of postponement and under penalty of cancellation, on the first day of the month following that in which the agreement is signed. Commencement of research activities must be documented in a declaration issued by the Head of the Department at which the research takes place.

The grantee is required to submit an annual report in writing on his/her activities to the Center in which his/her work is done together with the assessment of the head of the research project.

The research activities may be carried out abroad at a foreign university or research institution for a maximum of six months in any one year. Said foreign university or research institution will issue express certification, provided that it is in line with the research activities to be carried out. The period of stay abroad, within the limits indicated above, may be repeated from year to year. There are no time constraints when research is carried out abroad at universities or research institutions that have entered into collaboration agreements with the University for research activities related to the subject matter of the grant. For the duration of the stay abroad, the Department / Research Center may supplement the monthly grant with its own funds.

The grantee may undertake missions in the context of the research program. On the suggestion of the Head of Research, and with the approval of the Departmental Council, the grant holder may be given limited subsidiary or supplementary teaching assignments in the academic courses; said assignments may not, however, compromise the research activities. Said teaching tasks may not exceed a maximum of 50 hours in each academic year, and will be carried out in the form of teaching assistance, exercises, and seminars.

This teaching collaboration is not compulsory, must not have any effect on University of Naples Federico II's budget, and will not lead to any entitlement to a permanent position at an Italian university.

At the end of the grant period, the grant holder will present a detailed final report on the activities carried out for evaluation by the assessment committee established pursuant to Article 5, paragraph 1 of Law no. 370 of 19 October 1999. The award of a research grant does not constitute an employment relationship in any manner, and will not give rise to any right of access to a permanent position at the University

**ARTICLE 9 (Non-Accumulation; Incompatibility; Leave and Interruptions)**

Research grants cannot be held concurrently with any form of scholarship or for research activities unless they are awarded by national or foreign institutions for the purposes of supplementing, during an foreign assignment.

The grant is personal. On penalty of cancellation, beneficiaries may not combine it with income from professional activities or work performed on a full-time basis, except as set forth in Article 6, paragraph 4 of the Regulations Governing the Award of Grants for Research Activities.

Research grants are incompatible with enrolment for the entire duration of contract referred to in this call for applications, on degree courses, specialist or short Masters course, doctorate courses benefiting from a scholarship or medical specializations, in Italy or overseas, or on University Master Degree Courses.

Grants may be provided to personnel working in the Public Administration, provided that they are placed on unpaid leave for the duration of the grant.

The research activity is suspended on, both duly proved, compulsory maternity leave and illness, provided that the whole lasting of the check cannot be reduced due to these suspensions. A total period of justified absence of less than 30 days in a year doesn't have to be recovered.

**ARTICLE 10 (Automatic Termination of the Contract)**

In addition to the cases identified in Articles 8 and 9 of this notice, the contract will be automatically terminated with regard to persons who interrupt their activities without good cause or who are liable for serious breaches, where said termination is proposed by the Head of Research and approved by the relevant Departmental Board.

**ARTICLE 11 (Payments; Tax and Social Security Treatment)**

The grant will be paid net of charges due by the grant holder in equal monthly installments paid in arrears, except in the event of interruptions to the activities. Performance of the research activities in a regular and fruitful manner must be documented in a statement issued by the Head of the Department or Research Centre every four months.

With respect to taxation, fellowships are subject to the provisions of art. 4 of the Italian Law no. 476, dated 13th August 1984, and with respect to social security, to those of art. 2, paragraph 26 and following, of the Italian Law no. 335 dated 8th August 1995, and subsequent amendments. The following shall apply to research fellowships: provisions regarding the mandatory maternity leave, the provisions referred to in the Decree of the Italian Minister of Labour and Social Security dated 12th July 2007, published on the Official Journal (G.U.) no. 247 dated 23th October 2007, and, as regards sick leave, art. 1, paragraph 788, of the Italian Law no. 296 dated 27th December 2006, and subsequent amendments. During the mandatory maternity leave, the indemnity paid by the Italian National Institute of Social Security (INPS) according to art. 5 of the above Decree dated 12th July 2007 will be supplemented by the University up to the full amount of the research fellowship.

The University will provide the insurances coverage for accidents and the civil responsibility for holders of research grants related to their research

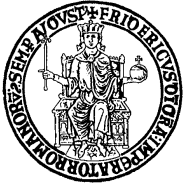

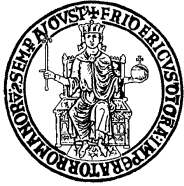
