2.1. Recommended language skills

The sending institution, following agreement with our institution, is responsible for providing support to its nominated candidates so that they can have the recommended language skills at the start of the study or teaching period:

- 1. The student must apply for the Free Spanish Language Course by checking the corresponding box in the Application Form.
- Students who have applied for the course, must take a <u>compulsory</u> level test that will be held at UCM the first week of September (for 1st semester/Full year students) and first week February for 2nd semester students. The exact date and place will be provided well in advance to each student by e-mail. Please, bear this course in mind for accommodation arrangements.
- The intensive language course will be developed along the month of September (for first semester or full year students) and February (for second semester students). This course is previous to the beginning of the Year/Semester. As mentioned above, this free course will be offered for levels under B-2 (B-2 included).

Students whose level is C-1 or C-2 are not eligible to attend the FREE Spanish courses. However,

2.2. Additional requirements

2.2.1. The number of students you will send may by no means exceed the number of students mentioned in this agreement. More specifically, we do not accept the mechanism by which shorter periods of stay allow for the sending of more students, i.e. on an exchange of 1 student for 10 months, you may not freely send 2 students for 5 months, not even if their stay covers different semesters. Please take this into consideration when organising your students selection

2.2.3. Staff Mobility for Training and for Teaching: Complutense University welcomes applications from foreign Staff for a training/teaching period, however it is at the discretion of the department concerned whether or not to accept a staff visitor. Applications must be sent to rrinter@ucm.es at least two months prior to the desired training/teaching period. The training/teaching period cannot be scheduled during Summer (i.e. July-August) in the Academic year.

2.2.4. Master level students (2 nd cycle) must in general have passed 240 ECTS credits. However, some Master students having passed only 180 ECTS may be accepted in Master level courses if their background is solid and approved by the master's coordinator. Students will provide the following documents to the International Relations office of corresponding Faculty/School: CV, transcript of records and motivation letter. The learning agreement of the student must be approved by the master's coordinator.

2.2.5. Admission to a specific course is subject to the exchange student being satisfactorily qualified for the chosen area of study and/or course level, and availability

2.2.6 PhD students need to send a master certificate to the International Relations office of corresponding Faculty/School. . PhD students will only receive ECTS credits if they complete courses at the host institution. Therefore, they will not receive any ECTS credits from the host institution for PhD-related research they undertake. The home institution is responsible for accrediting PhD students with ECTS credits for research completed at the host institution.

2.2.7. It is not possible for student to hand-in their final MA/PhD Thesis at the host institution. Final theses need to be graded by the home institution.

2.2.8. Credit load at UCM: Students will be awarded ECTS credits when they have passed the assessments corresponding to the courses to which ECTS credits are allocated.

- 1 full academic year= 60 credits
- 1 semester= 30 credits
- 1 term/ trimester= 15 credits

The ECTS Student Application includes: Student Registration filled ON LINE once printed Academic Recognition / Learning Agreement (please check with the UCM area coordinator for details on the Curricula) Academic Transcript These documents, with the original signatures and stamps from the home university have to be sent to us, by post. Its reception in our Erasmus Central Office closes the whole inscription process. Students must choose their courses among those offered by the Faculty in our University (exceptionally, they would be allowed to take a maximum of two annual or two semester courses each semester in a different area) Due to the overpopulation of our University, we are not able to split semesters, neither to accept extra students. We can only accept applications from students who have been nominated by their home university with which we have a formal bilateral agreement. We regret we are unable to accept Erasmus free movers.

We welcome Erasmus Exchange students coming to Universidad Complutense de Madrid (UCM). To be nominated students you need to contact the Erasmus Coordinator at home institution.

An Erasmus+ interinstitutional agreement between both institutions in the specific subject area is needed, otherwise mobility will not be possible.

Students must be nominated by their Erasmus Coordinator, by following next steps:

I. NOMINATIONS:

II. ACKNOWLEDGEMENT:

UCM confirms the receipt of the nominations by sending an email both to the partner university and the student. This email provides with further information related to the application procedure.

This acknowledgement email to the nomination does not imply acceptance!!!

Once students have received this acknowledgement e-mail, they can start the application process.

IV. LANGUAGE REQUIREMENTS:

An adequate knowledge of the Spanish Language is required, given that classes at UCM are mainly taught in Spanish.

At least B1 Level is required (According to the European Common Framework of Languages) **B2 is required in some faculties. Please see**<u>https://www.ucm.es/english/language-requirements</u>

Philology students, please see: <u>https://www.ucm.es/english/language-requirements#filol</u> Fine Arts students: CERTIFICATE Level B2 of SPANISH is required. All classes are in Spanish.

V. APPLICATION PROCEDURE

All Erasmus nominated students need to complete the UCM on-line **Application Form**.

All sections should be completed.

The application can be modified, saved and finally completed in multiple sessions before final submission. If any modification to the application is needed once it has been submitted online, please, do it by e-mail to: erasmus1@ucm.es

You must upload the following documents to your application:

- Photo (.jpg, .jpeg)
- Learning Agreement (signed and stamped by your home Institution) (.pdf)
- Transcript (.pdf)
- Languages certificate (only compulsory for Philology, Media & Communication Science, Commerce and Tourism and Geography & History and Fine Arts students)

You can submit your application once all the sections on the menu are marked with green checkmarks. No more changes will be possible after submitting the application!

If any modification to the application is needed once it has been submitted online, it will be done by e-mail.

Only complete applications sent within the application period can be accepted.

VI. ACCEPTANCE:

After checking applications, UCM will send an **acceptance email** both to the student and the partner institution.

Two other situations are possible:

<u>Refusal</u>: If UCM cannot accept a student, both the student and the partner institution will receive an email.

<u>Cancellation</u>: If a student withdraws from the program, the partner institution will inform UCM as soon as possible.
