Art. 1 – SUBJECT

Definitions:

Student mobility for traineeship: mobility aimed at offering students the opportunity to enrich their educational and professional curriculum through work experience and/or preparation of the degree thesis abroad. During the internship, students can work in public or private companies in one of the European countries participating in the Program.

Learning agreement for traineeship (LAT): a clearly defined work/internship plan approved by the Department's Erasmus Delegate or by another supervisor at the Department and the host institution.

Traineeship Certificate: certificate issued by the host institution, duly signed, indicating the results achieved during the internship period.

Delegato Erasmus di Dipartimento o da altro supervisore individuato dal Dipartimento: contact person for the internship period and for the signing of the LAT.

Long term mobilities: mobilities scheduled for periods between two months (60 consecutive days) and six months (180 consecutive days).

Short term mobilities: mobilities scheduled for short periods between 5 and 30 days.

* * *

The call for applications hereby published is to award **360** Erasmus+ mobility grants for traineeships lasting from **two months (120 consecutive days) to six months (180 consecutive days)** and from 5 to 30 days for short mobilities to be completed **by 31st October 2025**. Activities must take place exclusively in the following countries: the others 26 Member States of the European Union, the 3 countries of the European Economic Area (Iceland, Liechtenstein, Norway), and the candidate countries Republic of North Macedonia, Serbia and Turkey. **NO UK, NO SWITZERLAND. For students enrolled in bachelor's, master's and single-cycle degree programmes, the short-term mobility period must be combined with a period of virtual activity.**

All the students on a Bachelor's, Single-Cycle Master's, Master's degree programs and PhD and Specialisation Schools at the University of Naples Federico II regularly enrolled at the University of Naples "Federico II" for the academic year 2023-24, are eligible for selection, with the aim of carrying out traineeship or thesis preparation activities within companies, training institutions, academic institutions and other organisations. In accordance with Articles 5-6 of this call for applications, candidates must independently select the institution where they want to complete the traineeship period.

Doctoral and specialization courses scholarships that will not be awarded can be used by three-year, master's and single-cycle degree courses.

Art. 2 – ELIGIBILITY REQUIREMENTS

Eligible for selection:

- all students regularly enrolled in degree courses at the University of Naples Federico II for the a.y. 2023-2024 in accordance with article 1;
- have a knowledge of English or another functional language for the performance of activities at a B1 level minimum in accordance with article 3.

Through the Erasmus+ Program students may benefit from the Erasmus grant more than once, for a maximum of 12 months per study cycle, regardless of the number and type of mobility (for study and/or traineeship purposes). For students enrolled in single-cycle degree programmes combining Bachelor's and Master's degrees, the maximum number of months is 24.

Students may carry out the traineeship, **which must in any case be completed by 31st October 2025**, even after graduating, as long as:



1. **at the moment of submitting the application to participate in the selection, candidates are still regularly enrolled in a degree course at the University;**
2. **the final qualification, (i.e. the Degree, PhD and Specialization School Degree) is obtained before the departure for the foreign country (during the mobility period students may not change their status in any way, i.e. they cannot graduate)**
3. **the taineeship activities are finalized within one year following the graduation and, in any case, no later than 31st october 2025.**

Art. 3 - SUBMISSION OF APPLICATION

The application form must be completed starting from **the day of publication of this call till no later than 11.59 p.m. (23:59) on 4th June 2024,** according to the following instructions:

1. **STUDENTS ENROLLED IN A BACHELOR'S, SINGLE-CYCLE MASTER'S, MASTER'S DEGREE PROGRAMS MUST CAREFULLY FOLLOW THE INSTRUCTIONS SET OUT IN ATTACHMENT 1;**
2. **STUDENTS ENROLLED IN DOCTORAL PROGRAMS AND SPECIALISATION SCHOOLS MUST APPLY BY FILLING OUT THE FORM AVAILABLE AT THE FOLLOWING LINK:**

Uploading the following documents:

- a. CV in Europass format;
- b. certificate or statement of language knowledge (English or another functional language) for the performance of activities at a B1 level minimum, alternatively declaration according to Attachment 2 and Attachment 3;
- c. the training project to be carried out (free text max 1000 characters);
- d. latest ISEE (optional) Late transmission of the ISEE will not be allowed. Therefore, where not uploaded, the Erasmus+ and International Mobility Office will automatically assign the candidate the maximum bracket for the purposes of calculating MUR and University supplementary fees, with the sole exception of non-EU candidates.

Failure to submit the application by the deadline and in the manner specified in this article shall constitute grounds for exclusion from the selection.



Language proficiency of at least B1 level (QCER) **MUST** be owned after courses or tests in one of the following institutions:

1. international organisations and/or institutions recognised by the MIUR (<https://www.miur.gov.it/enti-certificatori-lingue-straniere>)
2. University Language Centre (CLA)
3. foreign universities where the student has carried out a period of Erasmus studies.

Students have to enclose to their candidatures a certification/attestation or a declaration *in lieu* of the certificate/certificate already obtained at one of these bodies/institutions, using only the form in Attachment 2. Missing to fill-in and sign the declaration and/or lack of information, needed to the subsequent verifications, will cause rejection of the candidature and scholarship withdrawal.

CERTIFICATES ISSUED BY LANGUAGE LECTURERS OF THE DEGREE COURSE, OR THE MERE RECORD OF LANGUAGE EXAMS INCLUDED IN THE DEGREE COURSE WITHOUT THE SPECIFIC INDICATION OF THE CEFR-LEVEL ACHIEVED WILL NOT BE ACCEPTED. THE OLS ASSESSMENT (Online Linguistic Support - Erasmus+) WILL NOT BE ACCEPTED.

EXEMPTION:

1. students enrolled in the LM37 class degree or already in possession of the L11 class degree.
2. students attending degree programs offered in English at the Federico II University.
3. mother tongue students.

The above-mentioned student will only have to upload the declaration in attachment 3.

Art. 4 - SELECTION

The selection of winners is the sole responsibility of the departments/schools, and is based on the following formulas:

BACHELOR'S DEGREE (LT) AND SINGLE-CYCLE DEGREE (Combined Bachelor's and Master's -LMCU)

$$Score = Average Marks * \frac{Actual CFUs}{Expected CFUs} 100\alpha$$

MASTER'S DEGREE (LM)

$$Score = \frac{\left(\frac{VLT}{110} 30\right) * 180 + Average Mark * Actual CFUs}{180 + Expected CFUs} 100\alpha$$

Where VLT is the final grade of the Bachelor's degree

For the DOCTORAL and SPECIALIZATION SCHOOLS degree courses, the evaluation will be carried out by the Departments and will focus on the basis of merit, motivation and linguistic knowledge.



Actual CFUs (university credits) correspond to those recorded within the **31st May 2024** (late or missing exams registrations are not responsibility of the ERASMUS+ AND INTERNATIONAL MOBILITY OFFICE; it is students' responsibility check the correct and prompt registration of the activities that might be useful to the determination of the score for this selection procedure – according to the existing internal regulations). The Erasmus Office will download students' data on **5th June 2024**.

Expected CFUs are, by convention, the maximum number of credits that students can have in the year of enrolment according to the following example scheme:

Each department may determine, if it wishes to apply it, the "α" factor, and/or add additional evaluation criteria to the objective score generated by the formulas above.

This information will be published on the websites of the respective individual departments.

As a point of clarification, candidates holding a degree obtained at a foreign university must verify that the graduation mark is present in their academic records and has been converted to the Italian grading system, namely, expressed on a scale of zero to one hundred tenths (66-110). If this information is not available in the academic records, it is the candidate's responsibility to contact the Student Office to request its inclusion.

Art. 5 – HOST INSTITUTIONS

The host institution may be, by way of example:

- a public or private organisation operating in the labour market or in the fields of education, training and youth;
- a local, regional or national public body;
- a social part or other labour representative, including chambers of commerce, associations of craftsmen or professionals and trade unions;
- a research institute;
- a foundation;
- a non-profit organisation, an association or an NGO;
- a body providing vocational guidance, career counselling and information services;
- a Higher Education Institute or University.

The following types of organisation are **NOT** eligible as host institutions for student traineeships:

- EU institutions and other EU bodies, including specialised agencies (the full list can be consulted at https://european-union.europa.eu/institutions-law-budget/institutions-and-bodies/search-all-eu-institutions-and-bodies_en);
- organisations in charge of EU programmes, such as ERASMUS+ National Agencies.

Art. 6 – SEARCH FOR HOST INSTITUTIONS

Candidates must select the host institution autonomously. By way of example, they may use the following tools:



- Universities with which the Federico II has entered into Erasmus agreements for study purposes.
- Departments' Erasmus webpages;
- Creation of an account on the following website: www.erasmusintern.org. By clicking on "sign up" and ticking the option "I'm looking for an internship", candidates can create their own profile and find the company/organisation that is best tailored to their study course goals and future career opportunities.
- Other databases belonging to the University;
- Any source and/or search tool (social media, personal contacts, intermediary agencies, etc.);
- On the website at the following link: <http://www.eaecnet.com>, accessing the International Internships section, where vacancies for internships abroad are posted on a regular basis.

Art. 7 - PUBLICATION OF THE RANKINGS

The rankings will be posted on the websites of each Department by **12th June 2024**.

Art. 8 – FURTHER OBLIGATIONS AND FILLING OF VACANCIES

Having identified the host organization, the students selected must draw up a carefully designed work/traineeship plan (**learning agreement for traineeship - LAT**) before their departure. Once approved by the Erasmus Delegate within the Department or by any other person in charge appointed by the Department and by the host institution, the LAT must be received by the Erasmus+ and International Mobility Office according to the instructions that will be published on www.unina.it within 20 days prior to the scheduled date of departure and in any case, for all, **by 30th January 2025**.

Students who have not presented the complete LAT by this date will be considered as withdrawn and it will be possible to proceed, in agreement with the department, to scroll through the rankings, with a dedicated notice published on the Erasmus page of the unina website by **25 February 2025**.

Once the LAT has been presented at the Erasmus+ and International Mobility Office, the place/company where the traineeship is held may not be modified in any way.

Art. 9 - ERASMUS AGREEMENT

Selected students, before leaving, will have to sign the Erasmus financial agreement following instructions which will be provided by the Erasmus+ and International Mobility Office.

Erasmus+ scholarships are compatible with any other form of funding, except of European funds covering the same costs.

Art. 10 - DURATION OF THE ERASMUS MOBILITY PERIOD AND FINANCIAL SUPPORT

The date of departure and the period to be spent abroad must be established in agreement with the host organisation and approved by the Erasmus Delegate within the Department, or any other person in charge designated by the Department.

Mobilities, both those scheduled for periods between **two months (60 consecutive days) and six months (180 consecutive days)** and those scheduled for short periods between **5 and 30 days**, must end in any case no later than **31st October 2025**. Please note that for students enrolled in bachelor's, master's and single-cycle degree courses, the short mobility period must be combined with a period of virtual activity.



For long term mobilities the scholarship is made up as follows:

1. An EU monthly allowance, shown in the following table depending on the destination country:

An additional €250 monthly contribution is also available for students in disadvantaged socio-economic conditions, with ISEE \leq €15,000 used for university purposes as submitted by the Erasmus grant winners for their enrolling to the a.y. 2023-24.

2. Further funding will be granted by the University of Naples Federico II and the Ministry of Education, University and Research on the basis of the ISEE certification used for university purposes as submitted by the Erasmus grant winners for their enrolling to the a.y. 2023-24. This is illustrated in the following table:

Art. 11 - ACADEMIC RECOGNITION

At the end of the study period abroad, the host University must issue the student with a duly signed certificate detailing the results achieved (**Traineeship Certificate**):

1. Students have to upload the Traineeship Certificate on MOBILITY.UNINA.IT and send it also the Departmental Coordinator;
2. PhD students and/or Specialisation Schools must send the Traineeship certificate by email to: **emanuele.barletta@unina.it** and to the Erasmus contact person of their Departmental Coordinator.

The missing uploading or transmission of the Traineeship Certificate at the end of the traineeship period, will entail the return of the complete amount of the received scholarship.

The University of Naples Federico II will guarantee the student full academic recognition of the activities carried out at the host institution, as agreed in the learning agreement for traineeship and on the basis of the results of the Traineeship Certificate, as an integral part of their course.

Art. 12 - PUBLICITY OF ADMINISTRATIVE PROCEDURES

This call for applications is published on the University website www.unina.it.

Art. 13 - ACCESS TO DOCUMENTS AND PROCEDURE SUPERVISOR

Candidates have the right to access the documents relating to the procedure pursuant to current regulations. This right shall be exercised in accordance with the University Regulations concerning administrative proceedings and the right to access documents, issued by Rectoral Decree no. 2386/98 as subsequently amended and supplemented.

ARTICLE 14 – DATA PROCESSING

Information on the processing of personal data pursuant to art. 13 of Regulation (EU) 679/2016 laying down rules on the processing of personal data and the code regarding the protection of personal data, Legislative Decree No. 196/2003 supplemented and amended by Legislative Decree No. 101/2018

By filling in, delivering and transmitting the forms required for participation in this selection notice, the student provides his personal data to the University of Naples Federico II and assumes the quality of "interested party" to the processing of such data pursuant to of the art. 4, 1) of the EU Regulation.

PURPOSES AND MEANS OF PROCESSING: The personal data provided during the application for participation or acquired subsequently during the relationship with the University will be processed for institutional purposes, in particular for administrative and accounting obligations related to the agreement. To this end, personal data such as name, surname, residence, personal data, tax code, contact details, address, email, data relating to the qualifications held, to the school career may be collected.

Personal data will be processed by authorized personnel both electronically, through the computerized management of the data, and in paper mode, through the collection, storage and use of documents in files, dossiers and archives.

MANDATORY PROVISION OF DATA AND CONSEQUENCES OF ANY REFUSAL: the processing of personal data is mandatory for the purpose of assessing the requirements for participation in the aforementioned call. Particular categories of data (judicial data and particular state of health) are provided voluntarily to allow the University to carry out the procedure and/or the provision of the related services for participation. For these



reasons, consent to the processing of data is not required. Any refusal will make it impossible for the University to fulfill these purposes and participation in the program.

COMMUNICATION AND DISSEMINATION OF DATA: Personal data will be processed for the performance of institutional activities according to the principles of lawfulness, necessity, non-excess, relevance and correctness, in accordance with European and national legislation and the University Regulations on the subject; the data may be disclosed in particular to the following subjects (Erasmus+ National Agency - INDIRE; European Commission, Ministry of Education, University and Research; University; Host company; Affiliated banking institution).

In compliance with the provisions on Transparent Administration (Legislative Decree No. 33/2013 and subsequent amendments) personal data, with the exception of the particular categories – referred to in articles 9 and 10 of the EU Regulation – are disseminated through publication on the university's institutional website for the period provided for by law.

RIGHTS OF THE INTERESTED PARTY: At any time the student may exercise his rights pursuant to articles 15-22 and 77 of the EU Regulation, where the conditions are met. 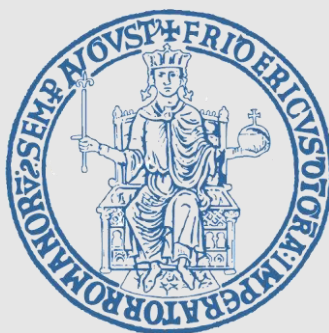

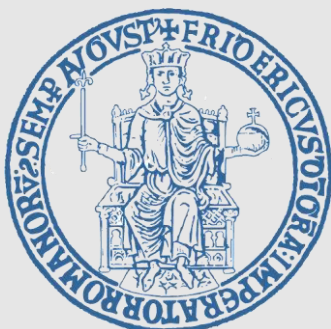
