- 3) not to be recipient and nor have been recipient of an Italian scholarship for attending a Ph.D. course, not even for only half the duration of the course;
- 4) to be aware that the scholarship cannot be combined with other scholarships awarded for any reason, except with those granted by national or foreign institutions to foster international mobility;

- 6) to be aware that the scholarship has an annual duration and is renewed provided that the student has completed the program of activities planned for the previous year and has been admitted to the following year;
- 7) to communicate any variation that would invalidate the right to receive the PhD scholarship, within 30 days from the occurrence of the situation itself. In this case it will return any scholarship accruals already received;
- 8) to have paid the Regional Tax for Education of € 140.
