2. Brief description and profile of Sant Boi Municipality

The municipality of Sant Boi belongs to the metropolitan area of Barcelona (AMB) and represents a generic "urban metropolitan area" with a territory with a confluence of a large number and a variety of important infrastructures in very little space, including energy and water supply infrastructures, train and train-related infrastructures, as well as telecommunications infrastructures, ...etc, which has a high degree of criticity within the AMB. Other singular infrastructures include an hospital, a commercial mall (Sant Boi Shopping Center: <u>https://ccsantboi.es/</u>) or a sport stadium. There are agricultural and natural spaces in the municipality. Therefore, it is possible to provide and to contribute to the design of the most suitable testbeds for projects , and makes available the necessary actors and resources for the implementation and demonstration of the case studies of projects, coordinating a set of end-users including first intervention teams, police, firefighters, owners of infrastructures, private security companies...etc, as well as policy actors and public

agencies as the Catalan Government, the Diputació of Barcelona or the Telecommunications centre of Catalonia to cite some examples.

Sant Boi has a network of research and industry partners with which they have ongoing collaborations and are keen to be incorporated in projects as required.

- 5. It has implemented platforms used for information management purposes: urbanism, public equipment, economic development, infrastructure
- 6. Future relevant mid-term plans: The municipality of Sant Boi is defining new projects to be implemented within the next years:
 - 3D mapping and crowd motion in the city with UPC-CIMNE. This is the first step towards a fully integrated crowd prediction and management tool that takes into account not only data gathered in real time from cameras, cellphones or other sensors, but also merges these with advanced simulation tools to predict the future state of the crowd.
 - Enhance the security in terms of access control implementing an Integration system, a suite of applications consisting of personalised SCADA for managing and integrating security systems, such as Intrusion, Fire, CCTV, Access, Visits, Accreditations, Patrols and also Automation and Control systems.

SmartCat Sant Boi's activities take place in the context of the project led by CTTI (Catalan Governement) **SmartCat**.

4. Owners of key facilities that can be involved:

The Sant Boi City Council team, lead by Zeljko Kulic, Head of the Public Equipments Service in Sant Boi City Council, have excellent relationships, and they are confident in involving in the project the owners of facilities such as Ceetrus (owner of most of the buildings in the commercial precint) and other infrastructure owners (RENFE, Ferrocarriles de la Generalitat...etc), as required.
