considering that:				

- By Decree MUR No. 3264 of 28 December 2021, the Ministry of University and Research issued a Public Notice for the submission of project proposals for the "Strengthening and creation of Research Infrastructures" to be funded under the PNRR National Recovery and Resilience Plan, Mission 4 "Education and Research" Component 2, "From Research to Business" Investment Line 3.1, "Fund for the creation of an integrated system of research and innovation infrastructures," financed by the European Union NextGenerationEU;
- In response to the aforementioned Public Notice, the University participated as a partner in the proposal "Innovative Research Infrastructure on applied Superconductivity", known as "IRIS", with project code IR0000003, led by the INFN National Institute for Nuclear Physics;
- As part of the IRIS Project, identified by code IR0000003, the acquisition of cryogenic equipment for the

characterization of superconducting devices is foreseen;

- With determination to contract No. 156712 dated 03/12/2024, this Administration decided to initiate an open tender procedure, to be awarded according to the criterion of the most economically advantageous offer, pursuant to Articles 71 and 108 of Legislative Decree No. 36/2023, as amended, for the "Supply of cryostats for the characterization of superconducting quantum devices."

## By means of this Act

The operator identified above expressly and irrevocably assumes all – without exception – the following obligations, burdens, and commitments, and therefore declares, pursuant to Articles 46 and 47 of Presidential Decree No. 445/2000, as amended, and with awareness of the criminal penalties under Article 76 of the same decree:

- 1. To have full knowledge of the tender documentation and to accept and comply with all provisions contained therein;
- 2. To undertake (if employing 50 or more employees and required to draft the report on the status of personnel pursuant to Article 46 of Legislative Decree No. 198 of 11 April 2006) to submit, under penalty of exclusion, a copy of the latest report prepared, along with a declaration of conformity with the version eventually submitted to company trade union representatives and to the regional equality advisor(s), or, in case of failure to meet the deadlines set by paragraph 1 of the same article, with a declaration of its simultaneous submission to those same bodies;
- 3. To undertake (if employing 15 or more but fewer than 50 employees and not required to draft the above-mentioned report under Article 46 of Legislative Decree No. 198/2006) to submit, within six months of the contract's conclusion, a gender equality report regarding the status of male and female personnel across professions and related to recruitment, training, professional promotion, classification, reclassifications, other mobility, use of wage guarantee funds, dismissals, early retirements, pensions, and actual remuneration paid. The operator shall also transmit said report to the company trade union representatives and to the regional equality advisor(s), under penalty of sanctions under Article 47(6) of Decree-Law No. 77 of 31 May 2021, converted with amendments by Law No. 108 of 29 July 2021;
- 4. To undertake (if employing 15 or more employees) to submit, within six months of the contract's conclusion, a report demonstrating compliance with the obligations under Law No. 68 of 12 March 1999 (on the right to work of people with disabilities), also detailing any sanctions or measures imposed on the company within the three years prior to the offer deadline. The operator is also required to transmit this report to company trade union representatives, under penalty of sanctions pursuant to Article 47(6) of Decree-Law No. 77/2021, converted with amendments by Law No. 108/2021;
- 5. To undertake (in the event of being awarded the contract) to ensure:
- That 30% of the hires needed for contract execution or related/auxiliary activities are allocated to youth employment (under 36 years of age);
- That 30% of the hires are allocated to female employment;
