Pursuant to articles 46 and 47 of Presidential Decree no. 445 of 28/12/2000, aware of the criminal sanctions, in the case of untruthful declarations and false documents, referred to in art. 76 and the consequent forfeiture of the benefits referred to in art. 75 of the aforementioned decree:

for the purposes of applying art. 53, paragraph 16-ter, of Legislative Decree no. 165/2001, introduced by law no. 190/2012 (activity following termination of the employment relationship – **pantouflage or revolving doors**):
