**WHEREAS** the current University Statute;

**HAVING REGARD TO** Law No. 168 of 9 May 1989, concerning, inter alia, the autonomy of universities;

**HAVING REGARD TO** Law No. 241 of 7 August 1990, as amended and supplemented, containing "New provisions on administrative procedures and the right of access to administrative documents";

**HAVING REGARD TO** Presidential Decree No. 445 of 28 December 2000, as amended and supplemented, containing the "Consolidated Act on legislative and regulatory provisions concerning administrative documentation";

**HAVING REGARD TO** Legislative Decree No. 82 of 7 March 2005, as amended and supplemented, containing the "Digital Administration Code";

**HAVING REGARD TO** Legislative Decree No. 198 of 11 April 2006 containing the "Code of equal opportunities between men and women", most recently amended by Law No. 162 of 5 November 2021;

**HAVING REGARD TO** Law No. 190 of 6 November 2012 on "Provisions for the prevention and repression of corruption and illegality in the Public Administration", as amended and supplemented;

**HAVING REGARD TO** Legislative Decree No. 33 of 14 March 2013, as amended and supplemented, containing the "Reorganisation of the rules concerning the right of civic access and the obligations of publicity, transparency and dissemination of information by public administrations";

**HAVING REGARD TO** Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, as well as on the free movement of such data (General Data Protection Regulation – GDPR), and the Personal Data Protection Code (Legislative Decree No. 196 of 30 June 2003, as amended and supplemented by Legislative Decree No. 101 of 10 August 2018, as amended and supplemented);

**HAVING REGARD TO** the University Code of Ethics, issued by Rector’s Decree No. 2425 of 11 July 2012, as amended by Rector’s Decree No. 2573 of 16 July 2015;

**HAVING REGARD TO** the Code of Conduct of the University of Naples Federico II approved by the Board of Directors with Resolution No. 87 of 26 November 2025 and, in particular, Article 2, paragraph 3, with regard to the case covered by this selection;

**HAVING REGARD TO** the current “University Regulations for Administration, Finance and Accounting”;

**HAVING REGARD TO** the current “Regulations of the University of Naples Federico II on the protection of personal data”;

## DECREES

### Article 1 Public Selection

The Department of Veterinary Medicine and Animal Productions of the University of Naples Federico II, hereinafter referred to as the "Structure", hereby announces, pursuant to Article 22-ter, paragraph 1, of Law No. 240/2010, the following

public selection based on qualifications and interview for the activation of no. 1 Research Appointment aimed at fostering introduction to research and innovation, intended for young graduates holding a Master's Degree or a Single-Cycle Master's Degree obtained no more than six years prior to the deadline of this call, hereinafter referred to as "Appointments", and possessing a curriculum suitable for supporting the conduct of research activities, within the framework of the CREMOPAR 2026 Project, with a duration of 12 months, possibly renewable.

The characteristics of the Appointments are set out in Annex A of this call, which specifies, in particular, for each Appointment:

- the scientific area of interest and the scientific-disciplinary sector
- the title and a brief description of the research programme
- the location and duration of the Appointment
- the gross annual amount net of charges borne by the University
- the Tutor
- the Scientific Disciplinary Group
- the Scientific-Disciplinary Sector
- the Scientific Coordinator, if already identified
- the maximum number of scientific publications or other research outputs that may be submitted for the purposes of this selection
- verification of knowledge of a foreign language: NO

### Article 2 Requirements for Admission to the Selection

Applicants, whether Italian or foreign, are eligible to participate in the selection, under penalty of exclusion, provided that, by the deadline for submitting applications, they meet the following requirements:

hold a Master's Degree or a Single-Cycle Master's Degree in the following degree classes or equivalent qualifications, obtained no more than six years prior to the deadline of this call: Animal Production Science and Technology (LM-86); possess a scientific curriculum suitable for supporting the performance of the research activities referred to in Article 1 above.

For academic qualifications obtained abroad, for which no formal recognition (equivalence) has already been granted, the



equivalence with the corresponding Italian qualifications shall be assessed by the Selection Committee, solely for purposes of participation in this selection.

### Exclusions

The following individuals are not eligible to participate in the selection:

those who are excluded from the enjoyment of civil and political rights;  
 those who have been dismissed, removed, or declared to have forfeited a public employment position in the Public Administration;  
 those who have been convicted by a final judgment (res judicata), including any ancillary penalties, crimes that prevent the establishment of any employment relationship with a public administration;  
 permanent staff employed on an open-ended contract by universities, public research bodies, institutions whose scientific specialization diploma has been recognized as equivalent to a PhD under Article 74, fourth paragraph, of Presidential Decree No. 382 of 11 July 1980;  
 those who have held fixed-term researcher contracts pursuant to Article 24 of Law No. 240 of 30 December 2010, as amended by Decree-Law No. 36/2022 converted into Law No. 79/2022;  
 those who have a familial relationship or affinity up to and including the fourth degree with a professor belonging to the Structure that proposed the activation of the research appointment, or with the Rector, the General Director, or a member of the Board of Directors.

The requirements for admission must be met both at the deadline of the call and at the time of signing the contract.

The Structure may, at any stage of the selection procedure, by means of a reasoned decree of the Director, exclude candidates in cases where the required qualifications are not met.

Candidates are admitted to this selection subject to verification of the requirements.

Exclusion and the reasons for it will be communicated to candidates exclusively by means of publication in pseudonymized form, indicating only the identification code of the application referred to in Article 3 below, in the online section of the University's Official Register as well as on the University website at the link:

Such publication shall have the value of official notification for all legal purposes.

If the reasons for exclusion are ascertained after the completion of the selection procedure, the Director of the Structure shall order the candidate's exclusion from the procedure and the annulment of all subsequent acts.

### Article 3

#### Submission of the Application

The application to participate in the selection, drawn up in accordance with the template set out in **ANNEX B** of this call, together with all attachments required under Article 4 below, must be submitted, under penalty of exclusion, starting from the date of publication of this call in the University's Official Register and no later than **16/06/2026 at 12:00 (Italian time)**; and, under penalty of exclusion, by one of the following methods only, excluding any other means:



## 1. Submission via Certified Email (PEC)

For applicants who hold a personal certified email address (PEC), the application must be sent exclusively from that PEC account to:

The subject line must obligatorily include:

“Application – RESEARCH APPOINTMENT, identification number of the call, surname and name of the applicant”.

Applicants who do not personally hold a PEC account must sign the application and declarations (as per Article 4) either digitally or with a legible handwritten signature, scan them, attach a valid ID document, and send them via a PEC account (also registered to another person) to the same address indicated above, with the same required subject line.

## 2. Submission via PICA Platform

The application, together with the required attachments, must be submitted exclusively through the online system PICA, available at:

no later than 16/06/2026 at 12:00.

To access PICA, candidates must register and authenticate using one of the following methods:

1. Institutional credentials of the University of Naples Federico II
2. Credentials issued by CINECA
3. SPID (Public Digital Identity System)
4. PICA account credentials (for those who do not have the above)

After authentication, applicants must complete the application, enter all required data, and upload all documents in PDF format, as specified in the online procedure.

The application must be signed (except when using SPID) using one of the following methods:

- Digital signature (smart card, USB token, or remote signature);
- Upload of a signed PDF using CADES format (.p7m);
- If digital signature is not available, print the generated PDF, sign it by hand on the last page, scan it, and upload it.

Any modification to the generated PDF prior to signing will result in exclusion.

### General Provisions

- No other methods of submission are permitted under penalty of exclusion.
- The application must be completed and submitted no later than 16/06/2026 at 12:00.
- Saving a draft does not constitute submission; the application must be finalized by clicking “Submit”.
- Submission is confirmed only when the application status changes from “draft” to “submitted”.
- A confirmation email will be automatically sent.

Each application will be assigned an identification number, to be used for all subsequent communications and in anonymized publications.

Once submitted, the application cannot be modified, only withdrawn and resubmitted within the deadline.

Technical issues must be reported via the “support” section on the PICA platform, indicating the application ID and call ID.



The Structure assumes no responsibility for technical issues related to PEC transmission or platform malfunctions.

### Declarations by the Applicant

In the application, the applicant must declare under their own responsibility (pursuant to Articles 46 and 47 of Presidential Decree No. 445/2000), and aware of criminal penalties for false statements:

- personal details (name, tax code, date/place of birth, citizenship)
- PEC address for communications, residence, phone number
- possession of admission requirements (Article 2)
- equivalence certificate (if degree obtained abroad)
- any foreign language for the interview (if applicable)
- enjoyment of civil and political rights
- (for foreign applicants) enjoyment of such rights also in their country
- no dismissal or removal from public employment
- no final criminal convictions preventing employment in public administration
- not being permanent staff of universities/research institutions
- not having held fixed-term researcher contracts under Art. 24 Law 240/2010
- no kinship up to the fourth degree with relevant university figures
- any previous research appointments under Art. 22-ter
- awareness of incompatibilities (Article 12)
- commitment to notify PEC changes

### Candidates with Disabilities

Applicants with certified disabilities (Law 104/92) must indicate required support for the interview and attach medical certification (without redactions).

The competent office, after evaluation (also by SINAPSI), will grant or deny such support via PEC.

### Final Provisions

The Structure may verify the truthfulness of submitted declarations. False statements are punishable under criminal law.

The Administration is not responsible for incorrect applicant information or technical issues.

If the selection is unsuccessful (no applicants or no winner), a new call may be issued, subject to project timelines and available funding.

## Art. 4

### Documents to be Attached to the Application

The applicant, under penalty of non-evaluation, must attach the following documents in PDF format:

- a copy of a valid identity document;
- a scientific-professional curriculum vitae, demonstrating suitability to support the research activities referred to in this selection, drafted in European format in both Italian and English, duly signed, and including all qualifications the applicant intends to submit for evaluation by the Selection Committee, drawn up pursuant to Articles 46 and 47 of Presidential Decree No. 445 of 28 December 2000, as amended and supplemented;



- a self-declaration (affidavit), pursuant to Articles 46 and 47 of Presidential Decree No. 445/2000, relating to academic and scientific qualifications held—both those required for participation and any additional qualifications considered useful for evaluation—indicating the issuing institution, the grade obtained, and the date of award (Annex C);
- publications, up to the maximum number set in this call, selected by the applicant, scanned in PDF format and accompanied by a self-declaration of conformity with the original (Annex C), together with a numbered list in progressive order;
- any additional qualifications deemed useful for participation, scanned in PDF format and accompanied by the relevant self-declaration of conformity with the original (see Annex C);
- for degrees obtained abroad, if already recognized as equivalent, the applicant must attach the relevant certification; otherwise, certificates of the foreign academic qualifications must be provided along with an official translation into Italian.

In accordance with established case law, applicants must indicate in their declarations/self-certifications, under penalty of non-evaluation, all elements relating to qualifications in a precise and analytical manner, to allow proper assessment by the Selection Committee and verification by the competent office. References to positions already held with other public or private bodies or to web links are not permitted.

The Selection Committee evaluates only the qualifications expressly declared or attached and assigns scores according to predefined criteria.

### Publications

- Publications must be listed in progressive numerical order.
- Applicants must comply with the maximum number of publications indicated in Article 1.
- If the number exceeds the allowed maximum, only those within the limit will be evaluated, according to the order listed.
- In case of discrepancies between the list and submitted publications, the list prevails.
- Publications listed but not submitted, or submitted but not included in the list, will not be evaluated.
- Publications must be submitted in their original language. If this is not Italian, French, English, German, or Spanish (as determined by the Structure), a certified Italian translation must be provided by the competent diplomatic or consular authority.

Only publications and works accepted for publication under current regulations are eligible. Internal notes and departmental reports are not eligible.

For works published in Italy, the applicant must self-certify compliance with legal deposit requirements (pursuant to Presidential Decree No. 445/2000 and relevant legislation).

For works published abroad, the place of publication must be indicated.

For all works, the following must be specified, under penalty of non-evaluation:

- title
- author(s)
- year of publication
- journal or type of publication (monograph/edited volume/other)
- ISBN/ISSN/DOI/PMID or equivalent identifier



The Structure reserves the right, at any stage of the procedure, to verify the truthfulness of declarations and attached documents. Applicants must therefore provide all necessary details clearly and accurately.

The Structure assumes no responsibility for errors made by applicants or for technical/IT issues affecting the submission of the application and attachments.

## Article 5

### Conduct of the Interview and Procedures

The selection will be carried out on the basis of qualifications and an interview, which will be conducted remotely via the **Teams platform**.

Any changes regarding the organization of the selection procedure will be promptly communicated by means of a specific notice.

The date and method of the interview will be announced within 10 days from the deadline of this call, by publication of a notice in the online section of the University's Official Register as well as on the University website at the following link:

Such publication shall constitute official notification for all legal purposes.

Therefore, candidates—except for those excluded from the selection procedure by means of publication of the relevant exclusion decree of the Department Director/Responsible Officer, in anonymized form indicating only the identification number of the application—must appear on the date and at the location indicated above, carrying a valid identity document (identity card, passport, driving license, boating license, firearms license, or other identification documents issued by a State administration, provided they bear a photograph and official stamp or equivalent marking). Failure to present such identification shall be grounds for exclusion from the selection procedure.

Absence of the candidate at the interview will be considered as withdrawal from the selection, regardless of the reason, including force majeure, except as provided below.

The public oral interview is aimed at assessing the candidate's aptitude in relation to the subject of the appointment, as well as knowledge of a foreign language (optional). It may be conducted in person or, where applicable, remotely via videoconference, ensuring in the latter case appropriate technical solutions to guarantee the public nature of the session, identification of participants, security and traceability of communications, and compliance with personal data protection regulations.

The interview shall be considered unsuccessful if inadequate knowledge of the selected foreign language (where applicable) is established.

In order to ensure participation without prejudice, candidates who are unable to attend on the scheduled date due to medical conditions related to pregnancy will be granted an alternative interview date. Dedicated facilities will also be provided for candidates requiring breastfeeding accommodations upon request.

or through notification of its remote conduct, without prejudice to ensuring its public nature with respect to other candidates.

Acceptance of such requests and rescheduling of the interview shall, however, be subject to the timeline of the research project and compatibility with the financial constraints of the contract.

## Article 6 Exclusions

Candidates are admitted to the selection subject to verification of requirements.

The following candidates are excluded from participation in the selection:

- those whose application has been submitted after the deadline set out in Article 3 above and/or by means other than those specified in Article 3;
- those who have declared possession of requirements different from those prescribed in Article 2;
- those who have failed to attach a copy of a valid identity document in the case of an application bearing a handwritten signature;
- those who have not signed the application with a handwritten signature (i.e. personally affixed, excluding stamped or digital signatures);
- those who are excluded from the enjoyment of civil and political rights;
- those who have been dismissed, removed, or declared to have lost their position in public employment within a Public Administration;
- those who have been convicted by a final judgment, including any ancillary penalties, for crimes that prevent employment in a public administration;
- those who have failed to provide the required declarations regarding possession of the admission requirements, or who have submitted false or non-compliant declarations, certifications, or documentation resulting in the absence of the prescribed requirements;
- those who have a familial relationship or affinity up to the fourth degree inclusive with a faculty member of the Department or Structure proposing the selection, or with the Rector, the General Director, or a member of the University Board of Directors;
- those who have held fixed-term researcher contracts pursuant to Article 24 of Law No. 240/2010;
- those employed on a permanent basis by universities, public research bodies, or institutions whose scientific specialization diploma is recognized as equivalent to a PhD under Article 74, fourth paragraph, of Presidential Decree No. 382 of 11 July 1980;
- candidates who, in the judgment of the Selection Committee, do not possess a curriculum suitable for supporting research activities.

The Structure may, at any stage of the selection procedure, by means of a reasoned decree of the Director/Responsible Officer, exclude candidates who lack the required qualifications. Candidates are admitted subject to verification.

If grounds for exclusion are identified after the completion of the selection procedure, the Director of the Department/Structure shall order the exclusion of the candidate and the annulment of all subsequent acts.

### Article 7

#### Appointment and Composition of the Selection Committee

The members of the Selection Committee responsible for carrying out the evaluation procedures for the awarding of research appointments are appointed by the Director of the Department by formal decree, after the deadline of the call and within the following 30 days, upon proposal of the Department Council.

The Director's decree appointing the Selection Committee is published in the online section of the University's Official Register, as well as on the University website at the following link:

The Selection Committee consists of three professors or researchers and one alternate member, normally ensuring adequate gender balance. The members belong to the scientific disciplinary group specified in the call, with at least one member, where possible, belonging to the scientific-disciplinary sector(s) defining the profile of the selection.

The Committee may use telematic tools for collegial work and may hold its meetings remotely, ensuring the security and traceability of communications and all proceedings.

Each meeting of the Selection Committee must be recorded in specific minutes.

### Article 8

#### Selection Procedures and Formation of the Merit Ranking

The selection is carried out through a comparative evaluation aimed at assessing whether candidates possess a curriculum suitable for performing the research activities covered by the selection.

The evaluation of qualifications is supplemented by a **public interview** intended to assess the candidates' aptitude for research. The interview may also be conducted in a foreign language requested by the candidate and indicated in the application, where permitted by the call.

The Selection Committee has a total of **100 points**, distributed as follows:

- a) **Relevance of the curriculum** to supporting research and innovation activities in relation to the scientific-disciplinary sector(s) of the selection: minimum 20 points, maximum 40 points;
- b) **Quality, originality, innovativeness, and relevance of publications** submitted with respect to the scientific-disciplinary sector(s) of the selection, as well as the individual contribution of the candidate: minimum 20 points, maximum 30 points;
- c) **Oral interview**, aimed at assessing aptitude for the research activity and knowledge of any foreign language specified in the call: minimum 20 points, maximum 30 points.

The interview shall be considered unsuccessful if inadequate knowledge of the foreign language is established (where applicable).



Candidates must obtain a **minimum of 40 points out of 70** in categories a) and b) combined in order to be admitted to the interview.

Within each category (a, b, c), the Committee predetermines additional evaluation criteria for assigning scores and judgments.

At its first meeting, the Committee verifies and declares the absence of any incompatibility situations, in accordance with Article 6, paragraph 8 of the applicable Regulations, and appoints a **Chair** and a **Recording Secretary** from among its members.

The Committee also establishes the detailed criteria for assigning scores and the procedures for conducting the interview, formalizing them in the minutes. These minutes are published in the online section of the University's Official Register and on the University website at:

The evaluation of qualifications is carried out prior to the interview. The results, including any exclusion from the interview, are communicated to candidates exclusively through publication in pseudonymized form (indicating only the application identification code) in the University's Official Register and website, with the value of official notification.

To be considered eligible, candidates must achieve a **minimum total score of 60 points out of 100**.

Upon completion of the evaluation and interviews, the Committee expresses a **collegial overall assessment** for each candidate and assigns the corresponding score.

The Committee then draws up a **merit ranking** of candidates who have passed the interview, based on the total scores obtained, and identifies the winner(s).

In case of equal scores, priority is given to the **younger candidate**.

Pursuant to Article 9 of the Regulations, the Committee must complete its work, including the preparation of the merit ranking and identification of the winner(s), within **90 days** from the publication date of the appointment decree. Upon justified request by the Chair of the Committee, an extension of up to **60 additional days** may be granted by the Head of the Structure.

The acts of the selection procedure are approved by decree of the Head of the Structure/Director of the Department within **60 days** from the submission of the minutes to the competent office.

The approval decree is published in the University's Official Register and on the website:

At the stage of approval, the merit ranking is also published: the winner(s) are indicated by name, while eligible non-winning candidates are identified only by their application identification code.

The **validity of the merit ranking** is set at **180 days** from the date of publication of the approval decree.

Publication in the University's Official Register has the value of **official legal notification** for all purposes.

## Article 9

### Execution of the Contract

The execution of the contract with the winner of this selection shall take place within **10 days** from the publication of the approval of the acts on the official University website.

The Structure shall invite the selected candidate via certified email (PEC) to proceed with the signing of the contract.



The selected candidate may submit a duly justified request for postponement to the competent Department office exclusively via PEC. Such request will be assessed in light of the timeline of the research project to which the appointment relates and the availability of financial resources.

At the time of signing the contract, the selected candidate must provide the following documentation:

- a valid identity document;
- tax identification number (codice fiscale);
- candidates holding a foreign qualification required for admission must, under penalty of exclusion, submit either a **Declaration of Value** or certification issued by **CIMEA** regarding the qualification used for access to the selection;
- for non-EU candidates residing abroad, the contract may be signed only after completion of entry visa procedures and obtaining a valid residence permit required for contractual purposes.

The contract must specify:

- a) the start and end date of the contract;
- b) the Department/Structure where the activity will be carried out and the name of the Tutor responsible for supervision;
- c) the scientific-disciplinary sector(s) and scientific disciplinary group related to the research and innovation activities;
- d) the research activities to be carried out;
- e) the total remuneration;
- f) the procedures by which the appointee must report activities to the Tutor;
- g) the grounds for termination of the contract and the **15-day notice period**;
- h) the grounds for withdrawal;
- i) provisions concerning intellectual property, data protection regulations, and confidentiality obligations;
- j) commitment to comply with the National Code of Conduct, the Code of Conduct, and the Code of Ethics of the University of Naples Federico II.

The contract is signed by the selected candidate and the Head of the Structure.

In the event of withdrawal by the selected candidate or revocation of the appointment, the available position may be offered to eligible candidates ranked next in the merit list, in accordance with Article 9, paragraph 4 of the University Regulations, and subject to the timeline of the research project and the limits of available funding.

## Article 10

### Performance of the Appointment

The holder of the appointment is required to carry out the activities *предусмотрен* in the contract and is entitled, for this purpose, to make use of the facilities and equipment of the Department/Structure of reference. The activities must be performed in accordance with the research programme and the instructions provided by the Tutor, who is responsible for supervising them.

Holding a research appointment does not give rise to any rights regarding access to academic positions. The appointee is subject to the health surveillance provided for by Legislative Decree No. 81/2008 at the expense of the University, as well as to the regulations governing workplace safety.

Any research activity carried out outside the physical premises of the Structure proposing the appointment must



be authorized in advance by the Head of the Structure, after consulting the Tutor.

The activity must be suspended during the period of mandatory maternity or paternity leave. For the cases expressly provided for in Article 22-ter, paragraph 6, of Law No. 240/2010, reference is made to the following article.

The period of mandatory maternity leave shall be recovered at the natural expiry of the contract, in accordance with the applicable legislation.

Research activities may be suspended in cases of serious illness or parental leave; in such cases, the suspension period may be recovered at the end of the natural duration of the contract, subject to agreement with the Tutor and within the limits of the available funding.

Periods of justified absence not exceeding a total of **30 days per year** shall not be considered as suspension and therefore do not need to be recovered.

For periods spent off-site with the consent of the Tutor and authorization of the Head of the Structure, holders of research appointments are entitled to mission allowances funded by the Structure, equivalent to those granted to PhD candidates.

At the end of the appointment, the holder must submit to the Department a **final report** on the activities carried out and the results achieved within the project, countersigned by the Tutor and accompanied by any publications (including those under publication), patents, and any other materials useful for evaluating the research conducted.

## Article 11

### Economic, Tax, Social Security and Insurance Treatment

The amount of the research appointment is **Euro 27,180.00 per year** (gross amount payable to the recipient, excluding charges borne by the Department/Structure) and will be paid in **monthly installments**.

Pursuant to Article 22-ter of Law No. 240/2010, research appointments are subject:

- for tax purposes, to the provisions set out in Article 4 of Law No. 476 of 13 August 1984;
- for social security purposes, to the provisions set out in Article 2, paragraphs 26 et seq., of Law No. 335 of 8 August 1995;
- for mandatory maternity leave, to the provisions of the Ministerial Decree of 12 July 2007 (published in Official Gazette No. 247 of 23 October 2007);
- for sick leave, to Article 1, paragraph 788, of Law No. 296 of 27 December 2006.

During the period of mandatory maternity leave, the allowance paid by the National Social Security Institute (**INPS**) pursuant to Article 5 of the aforementioned Ministerial Decree of 12 July 2007 is supplemented by the University up to the full amount of the remuneration for the research appointment.

Holders of research appointments are insured by the University, at no cost to them, for **third-party civil liability and accidents**, starting from the commencement of the research activity.

## Article 12

### Intellectual and Industrial Property of Research Results and Publications

The industrial and intellectual property rights relating to the results achieved by the appointee on behalf of the



University in the performance of their research activities shall be governed by the provisions of the University Regulations on industrial and intellectual property in force at the time the results are obtained.

Appointees awarded positions financed by entities external to the University shall review and accept the provisions concerning intellectual and industrial property contained in the agreement between the University and the funding entity. In any case, the inalienable moral right of the appointee to be recognized as author or inventor remains unaffected.

The holder of the appointment is required to sign a specific confidentiality agreement regarding any confidential information, data, and documents that they may become aware of in the course of their activities at and/or on behalf of the University.

In all cases, the holder of the appointment is guaranteed the possibility of carrying out ordinary publication activities as part of their academic development, provided that such activities are planned in a manner consistent with the protection of any potential research results.

Intellectual and industrial property rights relating to inventions or creations achieved by the holder of the research appointment in the course of their research activities belong to the University, without prejudice to the right of the inventor to be recognized as the author, in accordance with the law and University Regulations.

### **Article 13** **Incompatibilities**

Research appointments are incompatible with:

- a) enrolment in Bachelor's, Specialist/Master's Degree, PhD, or medical specialization programmes, in Italy or abroad, without prejudice to the possibility of participating in specific European Union research funding programmes within the Marie Skłodowska-Curie Actions (MSCA);
- b) holding a PhD scholarship;
- c) holding other scholarships, granted for any purpose by national or foreign institutions, except where these are aimed at international mobility for research purposes;
- d) holding research contracts pursuant to Article 22 of Law No. 240 of 30 December 2010;
- e) holding post-doctoral appointments pursuant to Article 22-bis of Law No. 240 of 30 December 2010;
- f) holding fixed-term researcher contracts pursuant to Article 24 of Law No. 240 of 30 December 2010;
- g) holding permanent employment contracts with universities, public research bodies, or institutions whose scientific specialization diploma has been recognized as equivalent to a PhD pursuant to Article 74, fourth paragraph, of Presidential Decree No. 382 of 11 July 1980.

Without prejudice to the above, the holder of the research appointment may not, under any circumstances, carry out activities that could give rise to a conflict of interest with the University's activities or that may hinder the proper performance of the research work.

In the event of requests to undertake additional assignments, without prejudice to the provisions of this article, the governing body of the Structure shall decide, taking into account the opinion of the Tutor and after assessing the absence of conflicts of interest and the compatibility of the assignment with the research activities.

Disciplinary matters are governed by Article 7 of Law No. 300 of 1970, as amended and supplemented; the procedures and sanctions fall under the responsibility of the Head of the Structure.



## Article 14

### Duration of the Research Appointment – Renewal

The research appointment is awarded for a duration of **12 months** and may be extended or renewed with the same individual up to a **maximum total period of three years**, including non-consecutive periods, as provided for by Article 22-ter of Law No. 240/2010.

For the purposes of calculating the maximum duration, periods of leave taken for maternity, paternity, or health reasons shall not be taken into account, in accordance with the applicable legislation.

Renewal, under the same conditions as the original contract, must be approved by the Department Council upon request of the Tutor, after verifying the availability of financial resources to cover the contract.

The renewal, granted by decree of the Director, is subject to a **positive evaluation by the Tutor** of the work carried out, as well as to the **actual availability of budgetary resources**.

## Art. 15

### Causes of Termination of the Contract

The termination of the employment relationship shall occur, in addition to any subsequent loss of eligibility, upon expiry of the term or withdrawal by either party, as well as for any other cause of termination provided for by applicable law.

Either party may withdraw from the contract prior to its expiry if a cause arises which, pursuant to Article 2119 of the Italian Civil Code, does not allow the continuation of the relationship, even on a temporary basis, or in the event of supervening impossibility.

The annulment of the recruitment procedure that constitutes the basis of this contract shall represent a condition for termination of the contract, without notice.

The holder of the research assignment may withdraw from the contract by providing written notice to the Structure, with at least 15 days' notice. Payment of the final instalment shall be proportionate to the period of activity actually carried out. In the event of failure by the appointee to give notice, the University shall have the right to withhold or recover an amount corresponding to the notice period not observed.

If the appointee, after starting the planned research activity, does not continue it regularly and uninterruptedly for the entire period without justified reason, or is responsible for serious and repeated misconduct or breaches, a procedure shall be initiated to declare termination of the contract, based on a justified proposal by the tutor and subject to approval by the decision-making body of the relevant Structure.

The specific grounds for termination may include the following:

- a) unjustified failure to start the activity or delay in its effective commencement;
- b) unjustified suspension of the activity for a period that adversely affects the research programme;
- c) violation of the incompatibility rules set out in Article 13 of the Regulations, repeated after an initial warning;
- d) failure to prepare the technical/scientific documentation required by the project, repeated after an initial warning.



## Art. 16

### Processing of Personal Data

The personal data of the Data Subject, including any special categories of personal data as well as any personal data relating to criminal convictions and offences, which the authorized staff of this Administration may acquire in the course of this procedure, shall be processed in accordance with Regulation (EU) 2016/679, the Personal Data Protection Code, containing provisions for the adaptation of the national legal system to Regulation (EU) 2016/679 (Legislative Decree No. 196 of 30 June 2003, as amended and supplemented by Legislative Decree No. 101/2018, as subsequently amended), as well as the current Regulation of the University of Naples Federico II concerning the processing of personal data.

The data collected will be processed for the purposes of this procedure for which they are provided and will be used exclusively for such purposes and, in any case, within the scope of the institutional activities of the University of Naples Federico II.

The Data Subject is entitled to the rights set out in Articles 15–22, 77 and 79 of the EU Regulation.
